High-stakes legal cases have been at the center of Michael R. DiStefano's legal career from the start. As an assistant district attorney and an assisant attorney general, he conducted 38 jury trials of cases involving narcotics, firearms and human trafficking as well as gang-related crime. He also served as a Safe Neighborhood Initiative prosecutor in Mattapan.

Entering private practice didn't lower the stakes for DiStefano or his clients. He's spent almost four years at Todd & Weld, helping to obtain an acquittal on arson and insurance fraud charges for a client in November 2017, as well as an acquittal on murder charges for a defendant prosecuted for participating with Aaron Hernandez in the 2013 shooting death of Odin Lloyd.

- **Q.** What's the most satisfying case or matter you've worked on so far?
- A. I have been blessed to help clients achieve great outcomes at trial as well as to successfully guide clients through complex government investigations. Results are important, but the most satisfying part of my practice is building the trust and personal connection with each client and the gratification that comes as a result of achieving a client's goal.
- **Q.** What is the best piece of professional advice you ever received?
- **A.** There is no substitute for hard work. Preparation is essential to any successful endeavor, especially in the courtroom.
- Q. Professionally, what keeps you up at night?

 A. I love the work, but some nights I can spend too much time analyzing the many decisions that I will make, whether in the courtroom, during a client meeting, in negotiations, or whatever else is on the next day's schedule.
