I really enjoy hopping from practice area to practice area I've worked on cases involving defamation, employment and even dabbled in some criminal law and family law in my pro bono
- **Q.** What's the most satisfying case or matter you've worked on so far?
- **A.** I worked on a pro bono case where a mother was brought up on truancy charges after she pulled her daughter from school, where she had suffered discrimination at the hands of teachers and other students for wearing a hijab. I was able to think on my feet and move to dismiss the case based on something the prosecutor said in court. It was a huge victory for that family and secondarily, I was able to come out with a very positive result in an arena that was completely new to
- **Q.** Have you been able to strike a work-life balance?
- **A.** I have. I went to law school when my daughters were in first and third grades, and today they are in high school and college. I worked very hard to stay involved with our
